For 40 years, uAspire has worked to remove financial barriers to postsecondary education, grounded in the belief that every student deserves the chance to build the life they envision. Since our founding, we've helped students secure financial aid, administered scholarships, and provided the guidance needed to pursue higher education and reach their goals. We have directly advised more than 125,000 students and used that experience to strengthen our Training, Policy, and Consulting work, extending our impact to more than 9 million students nationwide.





A MESSAGE FROM OUR CEO AND CHAIR OF THE BOARD

Dear friends

This past year marked a momentous milestone for uAspire, our 40th year supporting students on their journey to securing an affordable postsecondary education.

When uAspire first started, we advised students and provided scholarships in the Boston Public Schools. Since those early days, we've continually listened to the students and families we serve in order to grow and adapt our work. We've scaled our impact beyond one-on-one advising by leveraging technology and innovative practices to serve more students in new ways that meet them where they are. We've also drawn on our decades of experience to train and consult with organizations across the country, ensuring their students have access to uAspire's unique and critically valuable financial aid expertise.

A pivotal moment in our long history was the addition of resources and expertise to support systemic change. Our policy team now advocates for federal and state policies that are transparent, equitable, and built thoughtfully for the millions of students who face the biggest barriers to opportunity. We remain committed to supporting students as they navigate today's systems, while recognizing that the real work lies in building a better postsecondary and financial aid system for tomorrow.

It is a challenging time for higher education. The rise of AI, a shifting economic landscape, and continued questions about the value of a college degree – these challenges also present an important opportunity. Data shows that by 2031, 72%¹ of all jobs will require a postsecondary credential. Our higher education systems must adapt to meet these job market demands while remaining accessible and affordable.

Building on 40 years of frontline experience, uAspire continues to demonstrate the power of our model. In 2024–2025, uAspire helped unlock \$292 million in financial aid for more than 10,000 students across our advising programs.² **Students who work with uAspire are 1.5 times more likely to graduate, and those who engage most deeply are 1.9 times more likely to graduate.³**

While not every student can have a uAspire advisor by their side, these metrics drive our mandate for scale. With your partnership, we will continue developing solutions that ensure all students have the chance to succeed, no matter their background or circumstance.

As we celebrate this milestone, we remain committed to our work supporting students and families, distributing scholarship funds, building innovative partnerships, and advocating

for policies that create the higher education system of the future. Thank you for walking with us over the past 40 years and for continuing this journey with us as we build a future of access, affordability, and success for generations to come.




In 2024-2025, our core advising program supported 10,289 students across Massachusetts, California, and New York, including high school seniors applying for financial aid and current college students renewing it.

uAspire advisors guide students through every step—completing or renewing aid forms, reviewing financial aid offers, managing summer tasks, paying bills, and more. **With this support, uAspire students are 1.5 times more likely to graduate than their peers. Those who engage most deeply are 1.9 times more likely to graduate.³**





TRANSFORMING STUDENT EXPERIENCES INTO LASTING POLICY CHANGE

Informed by 40 years of experience and the daily insights of uAspire advisors, trainers, students, and educators, our Policy team works to make financial aid and higher education systems more equitable, simple, and transparent. Focused in states where our advising programs operate, we've advanced reforms that have **improved access for more than 805,000 students while driving progress nationwide.**

National



- Helped preserve Pell Grant eligibility and secure an additional \$10 billion through HR 1, the 2025 reconciliation bill.

California



- Secured \$20 million to backfill financial aid for community college students from mixed-status households concerned about federal data privacy.
- Ended "benefits displacement" by ensuring student grants, awards, and scholarships no longer reduce CalFresh or CalWORKS benefits.

Massachusetts



- Passed a requirement that each school district notify students about the FAFSA and provide information about federal and state financial aid.
- Increased state financial aid funding with greater support for low-income students.

New York



- Expanded funding for CUNY ACE and ASAP programs, which provide wraparound supports to help low-income students graduate.
- Increased state funding for early college and dual enrollment programs.

POLICY FELLOWSHIP

In 2024-2025, the uAspire Policy Fellowship trained 12 college students—each navigating the financial aid system firsthand—on how to advocate for change. Fellows learned to research solutions, write op-eds, speak at legislative briefings, and meet with policymakers, turning their lived experiences into meaningful influence.

ONE STUDENT'S JOURNEY TOWARD COLLEGE SUCCESS AND THE PROMISE OF WHAT'S NEXT

ELIAN (he/him) **Afford & Succeed Advising Student**

I moved from the Dominican Republic about five years ago, learned English from scratch, and graduated as my high school's valedictorian. College felt possible, but the financial aid process didn't. That changed when Angie, my uAspire advisor, came to my class and said, "When October hits, you'll need help. Come find me."

I did. During senior year, I spent my lunch breaks in her office, a quiet space where I got real answers. She walked me through FAFSA, reminded me about deadlines, and helped me tackle a big curveball when my U.S. resident card expired mid-application. We solved the problem with documentation and kept everything moving. I secured the aid I needed; it was enough to cover tuition—and even receive a refund.

It wasn't just forms. When considering skipping college altogether, Angie pushed back in a good way. "Try your first year," she said. "You've worked too hard to stop now." I thanked her in my graduation speech.

I'm currently studying Computer Science with a minor in Cybersecurity at Bridgewater State University. I'm applying to robotics and AI internships this summer so I can go straight into the field with experience after graduation.

Working with uAspire meant finding my path, while having someone who checked in, believed in me, and showed me what to do next.

INVESTING IN STUDENTS TO NAVIGATE COLLEGE AFFORDABILITY


Since our founding, administering scholarships has been a cornerstone of uAspire's mission to remove financial barriers to higher education. Each year, we award funds that make college enrollment and persistence possible for students who might otherwise be priced out of opportunity.

In 2024-2025, uAspire distributed \$400,538 in scholarships to 181 students through programs with partners including Bowdoin, CharlesNewtown, Chime, Harvard CBE, Massachusetts General Brigham, WinnCompanies, and the uAspire Last Dollar Program.

The need for scholarship support continues to grow, and so does our commitment. In collaboration with the Crankstart Foundation, Santander Bank, and Trailblazer Scholarship, uAspire is investing in new scholarships that will dramatically expand our reach over the next three years.

By 2027-2028, we anticipate increasing scholarship funds distributed to students by more than 17 times, reaching nearly 1,400 students.



The Launch of the Crankstart SF Scholarship

In fall 2025, with generous support from the Crankstart Foundation, uAspire launched the SF Crankstart Scholarship in four San Francisco high schools. The program reduces financial barriers to a bachelor's degree, lessens student debt, and supports scholars as they prepare for life after college.

The inaugural 200 scholars from the class of 2025 will receive up to six years of renewable scholarship support, totaling more than \$1.3 million annually, along with access to emergency funds, opportunity funds, and advising support that will help them persist and thrive through college.

Crankstart SF Scholar, attending UC Berkeley

Kathy didn't expect a scholarship process to feel personal until Crankstart. "The portal was so straightforward," she said. "And I loved that I could submit a video. It felt human." At Balboa High School, school staff hosted in-person sessions, pulling seniors into the library, and guiding them step by step, so applying didn't feel overwhelming.

Now at UC Berkeley (currently on the economics track), Kathy uses the debit card portion of the scholarship in the moments that matter: groceries between classes, laundry, and everyday necessities. In addition to direct cost coverage, the debit card is a unique yet valuable aspect of the scholarship, as "it doesn't disappear into tuition," she explained. "I can use it for real life."

She's also tapping into uAspire advising by texting quick FAFSA questions, attending budgeting workshops with guest professionals, and info sessions that keep college logistics manageable. "It's like texting a friend who knows what to do."

What stands out most to Kathy is the scholarship's local focus. "It's centered in San Francisco at specific high schools. It gives students like us more access to resources we don't always have."

"The scholarship makes the next four years feel stable," she said. "It's helping me adapt to college, focus on my goals, and figure out what comes next, at my own pace."
